## **Section D: CLUB AGREEMENT and CONDITIONS**

By initialing each section below, I acknowledge that I have read and understand each section/rule and I hereby agree to abide by these Club Conditions:

### **Initial:**

\_\_\_\_\_ Payment for Group Lessons should be paid on the first appearance in class for that month. Payment made after the 15<sup>th</sup> of that month is subject to a \$25 penalty fee.

\_\_\_\_\_ Payment for Private Lessons should be made prior to or at the start of each lesson taken, unless prearranged with the coach to bill at the end of the month.

\_\_\_\_\_ Private Lesson Cancellation needs to be made 24 hours in advance otherwise I will be liable for the missed Lesson.

\_\_\_\_\_ The Coach's fee for Local Competitions will be \$50 per day per fencer. Local is defined as within a 50 mile radius from BFC.

\_\_\_\_\_ The Coach's Fee for Away Competitions (USFA and World Cups) will be \$125 per day per fencer plus travel expenses which will be proportionally spread among BFC participants at that competition.

### **Section E: FEE SCHEDULE**

#### **1. Annual Membership \$560 (September – June)**

- ½ September 15
- ½ October 15

#### **2. Monthly Group Classes:**

- **Member: \$400, \$300, \$220, \$200, or \$180 per month, depending on Program**
- **Nonmember: \$350 per month**

#### **3. Private Lessons:**

- **Member: \$35 and \$40**
- **Member w/o group classes: \$45 per lesson**
- **Nonmember: \$55 per lesson**

#### **4. Floor Fees:**

- **Member: \$0**
- **Nonmember: \$15**

#### **5. Membership Discounts:**

- **Families of 2 shall receive a 20% Membership Discount on the subsequent membership**
- **Families of 3 or more shall receive a 30% Membership Discount off the subsequent memberships**

### **Section F: INDIVIDUAL PROGRAM FEES:**

#### **1. ELITE Program: (Coach's Invitation Only)**

- Group Class 3 days per week @ \$400 per month - includes 2 ½ hrs per class of footwork, drills and supervised bouts**
- Private Lessons at least 3 per week @ \$120**
- Total cost per month is \$880**

**2. ADVANCED Plus Program: (Coach's Invitation Only)**

- a. Group Class 3 Advanced & 1 Elite class per week @ \$300 per month
- b. Private Lessons at least 2 per week @ \$35 / \$40 per lesson
- c. Total cost per month is \$580 - \$620

**3. ADVANCED Program:**

- a. Group Class 3 days per week @ \$220 per month
- b. Private Lessons at least 1 per week @ \$35 / \$40 per lesson
- c. Total cost per month is \$360 - \$380

**4. INTERMEDIATE Program:**

- a. Group Class 3 days per week @ \$200 per month
- b. Private Lessons at least 1 per week @ \$35 / \$40 per lesson
- c. Total cost per month is \$340 - \$360

**5. BEGINNER Program:**

- a. Group Class 3 days per week @ \$180 per month
- b. Private Lessons at least 1 per week @ \$35 / \$40 per lesson
- c. Total cost per month is \$320 - \$340

**6. NON-MEMBER Program Fees:**

- a. Group Classes: \$350 per month
- b. Private Lessons: \$55 per lesson
- c. Floor Fee: \$15 per day
